


If not confirmed otherwise life Animals, Removal goods, Heavy cargo and Salvage cargo.

Restrictions for compulsory liability insurance (section 7 a, German load haulage law, GüKG, and section 104, number 3 German air traffic licensing order, LuftVZO)

In deviation from other insurance policy provisions, reimbursement by the insurer is limited to a maximum of € 600,000.00 for all claims and losses per loss incident and loss event as well as € 1.25 million for all loss events in an insurance year. Sections 113 et seq. German Insurance policy Act, VVG, particularly section 114, par. 2, sentence 2 VVG, are applied.

**Deductible:**

The excess per each claim is € 2.500.00.

**Insurance period:**

The insurance contract is valid from **01.01.2021** until **31.12.2021** will be renewed tacitly for one year, unless cancelled with three month notice by either party and premium paid.
